

ABSTRAK

Tujuan penelitisn ini adalah untuk mengetahui Permasalahan ekonomi yang terjadi dalam kerjasama NAFTA antara Amerika Serikat, Meksiko dan Kanada dimana Amerika Serikat menganggap NAFTA memberikan defisit, dan aturan lama dalam kesepakatan NAFTA harus diperbaharui agar memberikan keuntungan yang dianggap adil bagi ketiga negara anggota yang tergabung dalam perjanjian NAFTA, bagaimana lobby yang dilakukan Presiden AS terhadap kongres AS untuk mendapatkan persetujuan atas kebijakan renegotiasi yang akan dilakukan, dan apa hasil tujuan yang akan didapatkan AS atas hasil negosiasi di masa depan saat perjanjian tersebut sudah berlaku .

Penelitian dilakukan secara Deskriptif dan teknik pengumpulan data dilakukan dengan “Studi Kepustakaan” atau *library research*. Hasil dari penelitian yang didapatkan bahwa Kepentingan AS terkait renegotiasi ulang perjanjian NAFTA adalah untuk meningkatkan neraca perdagangan dan mengurangi defisit perdagangan dengan negara-negara anggota NAFTA karena perjanjian ini dianggap telah berkontribusi pada peningkatan defisit perdagangan, juga memperbaharui aturan lama dan dibuat sesuai dengan perkembangan teknologi.

ABSTRACT

The purpose of this research is to find out the economic problems that occurred in NAFTA agreement among the United States, Mexico and Canada, where the United States considers NAFTA to give a deficit, and thinks that the old rules in the agreement be amended to offer benefits that are fair for the three countries. How the the US President carried out lobbying against the congress to get an agreement on the policy of renegotiation, and what the results of the objectives will be obtained by the US on the results of negotiations in the future when the agreement is in force.

The research was conducted descriptively and the material was collected by Literature Study or library research. The results of the research found that the US Interest in the renegotiation of the NAFTA agreement is to improve the trade balance and reduce the trade deficit with NAFTA member countries because this agreement is considered to have contributed to the increase in the trade deficit, also updated the old rules and made in accordance with technological developments.
