

ABSTRAK

DUKUNGAN UNITED NATIONS DEVELOPMENT PROGRAMME TERHADAP KEBIJAKAN LEGALISASI LESBIAN, GAY, BISEXUAL DAN TRANSGENDER

Isu LGBT kini tengah menjadi perbincangan hangat di seluruh dunia. Perserikatan Bangsa Bangsa (PBB) melalui *United Nations Development Programme* (UNDP) secara resmi mendukung legalisasi kebijakan *Lesbian, Gay, Bisexual and Transgender* (LGBT) ditengah perdebatan mengenai isu LGBT ini. Menurut PBB, hukum diskriminatif ini memelihara stigma, kekerasan dan merugikan kesehatan masyarakat karena mencegah akses vital terhadap layanan kesehatan termasuk perawatan HIV. Badan Pembangunan PBB (UNDP) mengatakan diskriminasi terhadap orang-orang gay dan minoritas seksual dan gender lainnya tidak hanya terbatas pada pekerjaan dan pendidikan saja tapi meluas ke kantor-kantor pemerintah dan sistem pengadilan. UNDP menambahkan kekerasan fisik dan emosional masih menjadi kenyataan khususnya dilingkungan keluarga, diskriminasi terus merugikan pekerjaan orang-orang LGBT (*lesbian, gay, biseksual, transgender, interseks*), memperkecil prospek karir dan potensi ;belajar mereka di sekolah-sekolah. Dengan berbagai permasalahan yang dialami oleh kaum LGBT mendorong UNDP untuk memberikan dukungan dalam pelegalisasian kebijakan LGBT.

ABSTRACT

The issue of LGBT is currently a hot topic of discussion around the world. The United Nations (UN) through the United Nations Development Program (UNDP) has officially supported the legalization of Lesbian, Gay, Bisexual and Transgender (LGBT) policies amid the debate over this LGBT issue. According to the United Nations, this discriminatory law maintains stigma, violence and harms public health because it prevents vital access to health services including HIV care. The United Nations Development Agency (UNDP) says discrimination against gay people and other sexual and gender minorities is not just limited to jobs and education but extends to government offices and the court system. UNDP added that physical and emotional violence is still a reality, especially in the family environment, discrimination continues to harm the work of LGBT (lesbian, gay, bisexual, transgender, intersex) people, reducing their career prospects and learning potential in schools. With the various problems experienced by LGBT people, UNDP encourages UNDP to provide support in the legalization of LGBT policies.
